**Job Description:** Reporting to the Executive Director, the Finance Director will be responsible for the internal infrastructure, policies, and systems to achieve agency financial and strategic objectives. As a member of the senior management team, the director will be involved in strategic planning and will lead the development of Mid-Columbia Children's Council annual budget. The Finance Director will continue to perfect capacity in key areas, including finance and financial reporting, accounting, development, grants and contracts, risk management, physical infrastructure and compliance with Head Start and governmental accounting standards and practices.

**Job Requirements:** Bachelor's degree in Accounting, finance or related field, advanced degree preferred. Experience with federally-required audits, grant monitoring visits, cost allocation plans, and Office of Management and Budget circulars. Five years of experience in accounting/financial management, preferably with nonprofit entities. Must have the ability to be bondable. Two years supervisory/management experience. Depending on time of year (budget cycle, year-end, etc.) work may extend beyond a typical 40 hour week.
