Job Description: Position serves to support families towards the fulfillment of their child's cognitive, language, literacy, social/emotional and physical growth, and development. Promote and maintain a high level of parent involvement and deliver family support services to promote greater self-sufficiency for at-risk children. Position responsibilities include making weekly home visits to implement curriculum-specific activities, providing group socialization experiences to parents and children, advocacy, and crisis intervention, maintaining on-going contact with families, and working with all components (health, nutrition, family services, education, disabilities, and mental health) to integrate services into the family setting.
